lifestyle. To compound this, there is a severe shortage of affordable rental housing throughout Long Island. The result is a substantial decrease in the number of 18 to 34 year olds here on Long Island – a demographic that is essential to Long Island's growth and survival."

Giving Long Island's young people places to live, work and play will help to attract and retain the next generation – as well as provide additional tax revenue to our schools and local governments – here on Long Island, Deegan Dickson added. Deegan Dickson is former counsel to the City of Glen Cove planning and zoning boards, and currently represents many developers, property owners, corporations and private individuals in all types of matters involving real property transactions, zoning and land use.
