However, when emotions control the decision making process, as in family business disputes or sensitive employment disputes for example, I take into account these factors as they frequently affect my ability to reach a reasonable resolution at the early stages of a conflict."



"Overall, understanding the client's objective from the outset, managing their expectations in terms of results and cost throughout the case, and being realistic with those expectations, in my opinion, is the best approach for the effective representation of a client," Curto said.

Prior to joining the firm in 1999, Curto was a partner in a Melville law firm. He has substantial experience in appellate practice, and has gained valuable experience from prior employment with the United States Environmental Protection Agency, the Suffolk County District Attorney's office and Matthew Bender Co., a well-known legal publisher.
